Position & Description:

Surveillance Installer – based out of our Las Vegas, Nevada Office.

This position is a career opportunity for qualified Installation candidates. Day to day tasks include pulling cable, racking equipment and inspecting final site work to ensure clean video camera/cable install and configuration of the system. Work with engineers to provide solutions to system malfunctions or challenges prior to departing the install site. Installers will be required to issue end-user system training post installation. Clear concise communication with design and technical team is required to best assist each client and help maintain our 100% on-time job completion record.

Requirements:

- High School Diploma or certified equivalent (GED) along with good skills related to reading, writing, and basic math.
- At least one (1) year of paid experience as an Installer with CCTV, networked video systems and low voltage wiring experience. Required Certifications: Comp TIA and Net+. In addition, applicants with A+ certifications are preferred.
- Knowledge and experience with access control and alarm systems a plus.
- Good foundation in structured cable installations.
- Posses mechanical abilities and knowledge required to properly install system hardware and cabling.
- Candidate must be willing to travel for out of town projects.
- History of working in a safety-first manner, not just for applicant but for all those related to job site and work at hand.
- Ability to lift or move up to 50lbs, climb/work from ladders, work in confined spaces and utilize all the applicable hand tools required on each job site.
- Maintain valid California Driver’s License along with minimum point count to be verified upon hire and periodically thereafter. Applicant must also be insured as required by law and be able to submit continual evidence of such.
- Legally able to work in the United States with proof of such that can be verified through the Federal E-Verify system.
- Candidate must be able to pass an initial and periodic drug test, as well as a security background check. In addition, Federal background checks required due to security clearance requirements requested by our clients prior to job site access.

Duration, Hours & Wage:

- SSI is an "at will" employer.
- Position is a full-time hourly position and hours may vary due to frequent travel, workload and/or market conditions. The general daily work schedule will be Monday thru Friday 7am – 4pm and frequent overtime may be required.
- Meal periods and rest breaks will be available and provided as outlined by law, agreement, or individual need.
- Wage range for this position starts at \$18/hr to \$26/hr depending on experience.
